Sub : Direct to Educational Councils to ensure all its recognized Institutions under them to onboard in National Academic Depository.

Dear Sir/Madam,

As you aware, National Academic Depository (NAD), which is a 24X7 online storehouse of academic awards (degree, diploma, certificates, mark sheets etc.) logged by the boards/academic institutions/eligibility assessment bodies in a digital format. The Ministry of Education (MoE) has designated the University Grants Commission (UGC) as an authorized body for implementation of NAD and DigiLocker (National e-Governance division), Ministry of Electronics and information Technology (MeiTY), Government of India is the digital depository for NAD who will keep the academic awards in the digital format and ensure the data integrity.

The Academic Institutions viz. Central Universities, Central Higher Educational Institutions and institutions empowered by an Act of Parliament to grant degrees, diploma etc., State Universities, Deemed to be Universities and other Universities, Certificate/ Diploma and Degree Awarding Institutions set-up under various other Ministries/Departments of Govt. of India, institutions approved by the Ministry of Skill Development and Entrepreneurship (MSDE), CBSE, State School Boards and other boards & all other Educational Councils are required to enter into DigiLocker, in order to onboard NAD for lodging their academic awards.

In view of above, I request the Heads of all educational councils to send letter to the institutions recognized under them to ensure their participation in NAD Project.

It is also requested to provide us a copy of that letter along with a detailed list of those institutions.
